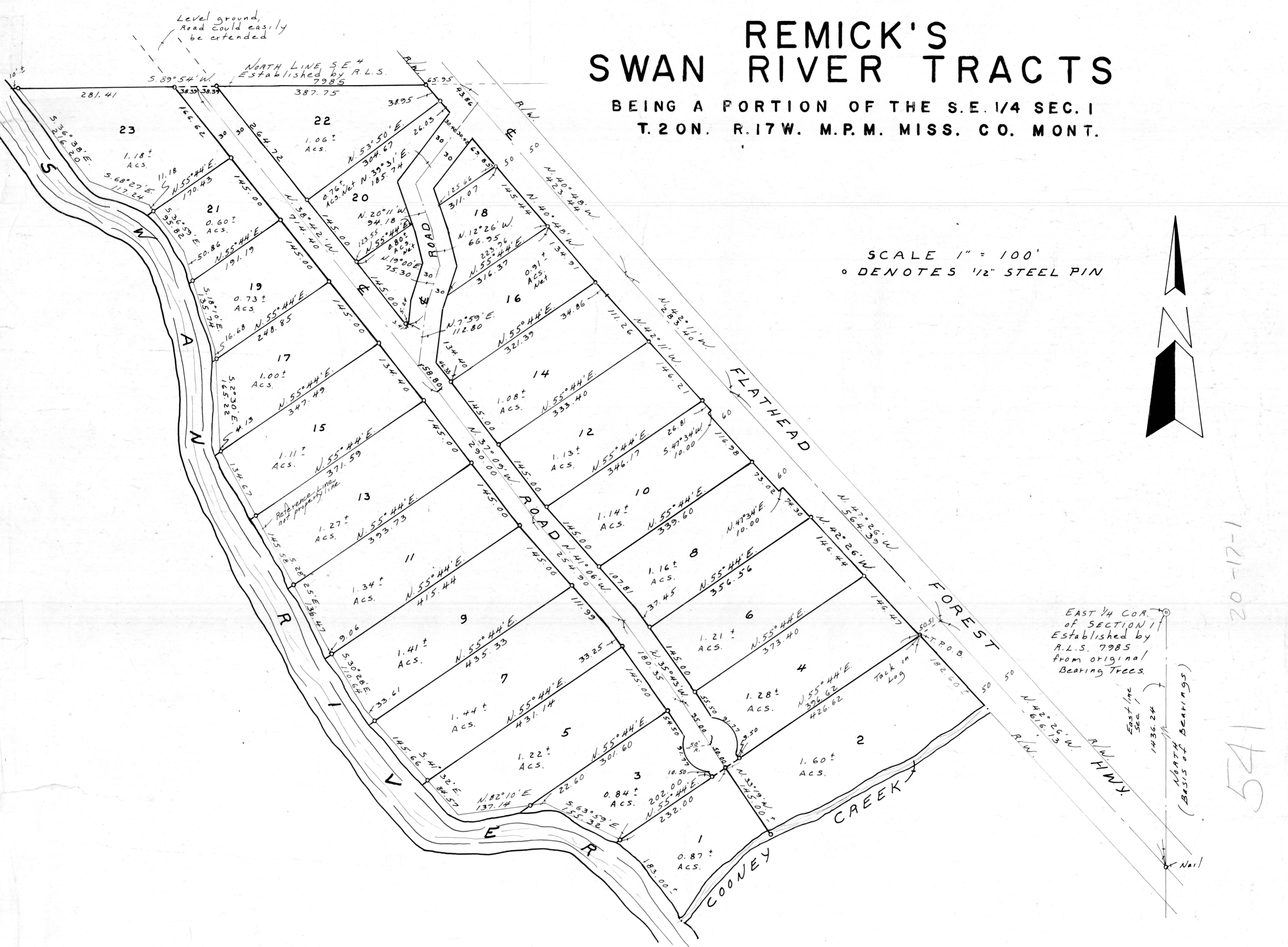
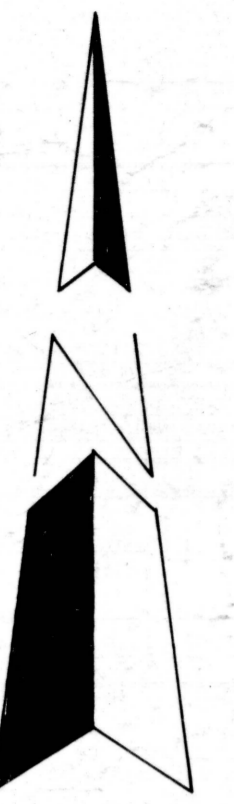


REMICK'S SWAN RIVER TRACTS

DEDICATION

WE, W.E. REMICK and EDMEE M. REMICK, husband and wife, do hereby certify that we have caused to be surveyed, subdivided and platted into lots and roads as shown on the accompanying plat and certificate of survey of the hereunto annexed the following described tract of land, to-wit:

Beginning at a point on the westerly R/W of the Flathead Forest Highway that bears South along the east line of said section 1, 1436.24 feet to the E of said Highway, N 42° 26' W 616.13 feet along the E of said Highway and S 55° 44' W 50.51 feet from the East 1/4 Corner of said section 1, thence along said westerly R/W N 42° 26' W 367.21 feet; thence S 47° 34' W 10.00 feet; thence N 42° 26' W 180.00 feet; thence N 47° 34' E 10.00 feet; thence N 42° 11' W 284.28 feet; thence N 40° 48' W 510.88 feet to the North line of the S.E. 1/4 of said section 1; thence along said North line, S 89° 54' W 755.94 feet to the easterly side of the SWAN RIVER; thence southeasterly along said River to the E of COONEY CREEK; thence Northeasterly along the E of said Creek to the westerly R/W of said Flathead Forest Highway; thence N 42° 26' W 182.50 feet to the point of beginning.
