The property comes with water rights including pond storage rights, spring rights and ditch irrigation rights.

The land is located in Game Management Unit 84. With the use of the bordering San Isabel National Forest and Greenhorn Wilderness, this property offers access to thousands of acres of remote back country. This game unit is known for producing trophy elk and mule deer and animal signs are seen throughout the ranch. The land also offers superb turkey hunting. The property is a recreational base for many activities with over 300+ days of sunshine and fresh mountain air. Enjoy horseback riding, hiking, ATV use, camping, hunting on the property or in the nearby San Isabel National Forest. The property is directly accessible to the Greenhorn Mountain Trail which is a scenic hike to the top of Greenhorn Mountain. The land is also only 20 minutes to beautiful San Isabel Lake and the iconic Bishop's Castle.
