

The property belonging to us is approximately 417 acres of virgin forest without erected building including a large sandy beach, a field with an airstrip, 3 small beaches and a breathtaking view lookout.?

Ownership of this island property grants legal access to a mainland dock, beach and parking. Major Island's surrounding Lac-des-Îles is a fishermen's dream, home to many species including walleye, muskie and pike. Nearby Mont-Laurier, known as the capital of the High Laurentians, is just a 15-minute drive away, and offers a wide range of facilities and services, including golf, skiing, cycling, a cinema, a hospital and shopping facilities. Also nearby are Mountain du Diable Regional Park, and the well known P'tit train du Nord, a 144-mile cycling trail along a disused rail line.

The property is already subdivided into a large number of individual lots with projected paths in acquired rights. (see appendix) Straddling two municipalities. The plan is made of 48 waterfront lots and 44 other lots with waterfront access. In addition, 8 lots totaling 1,500,000 square feet can actually be subdivided into 25 new waterfront lots and another 100 lots that will have waterfront access water, for a grand total of more than 200 lots.
