

Since 2016, the residence has had numerous updates to include new windows, updated bathroom, all new plumbing, new flooring, and a new hot water heater (replaced in 2023). An exterior wood-burning furnace serves as a supplementary heat source for interior air temperature and hot water. Outside of the residence is a detached 30x50 +/- foot Cleary pole barn with concrete floors and electricity which was built in 2015. The owner currently has a couple acre area of pasture that is fenced in with cow panels where he raises sheep. Inside this inclosure is a historic barn (also with electricity) that is currently used by the livestock. A beautiful 1+/- acre stocked pond is also situated on the premises. 13 +/- acres of tillable ground provides a great source of supplemental income. The balance of the property is in timber with a mature stand of white oaks and deep draws making this an excellent hunting tract!
