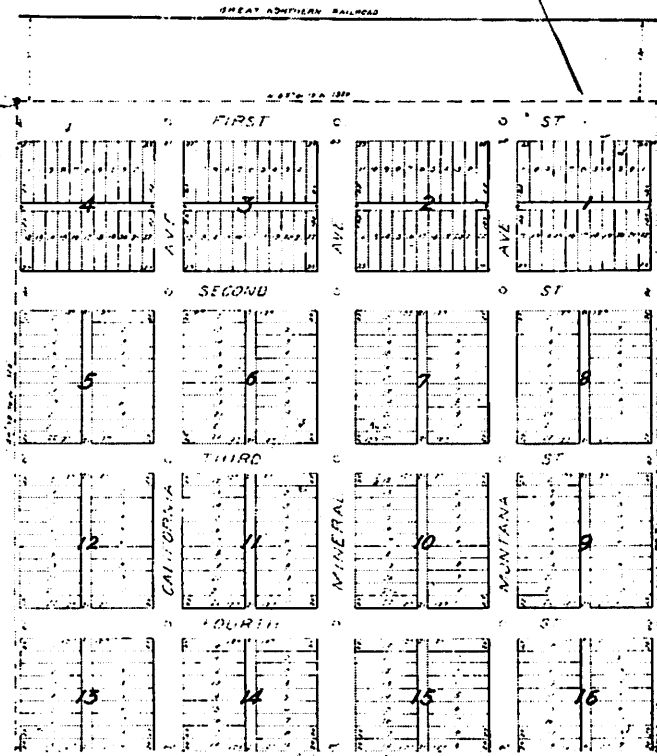

CERTIFICATE OF DEDICATION

I, Everett L. Reed, do hereby certify that I have caused to be surveyed and divided and platted into lots, blocks, streets and alleys, in accordance with the plat and certificate of survey hereto annexed, the following described tract of land, to-wit: Beginning at a point which bears South 14° 29' 42" E. 241.72 feet from a certain point at the confluence of Flour Creek with the Redstone River, bearing South 24° 10' 30" West 1320.11, thence South 63° 01' 10" East 1532.01, thence South 63° 01' 10" East 1320.11, thence North 63° 01' 10" West 1520.11 to place of beginning, and containing 16 lots, to be known as Libby, Missoula County, Montana, and the streets and alleys therein named, and alleys hereon designated, to them by donation to the public use, and forever to ever.
