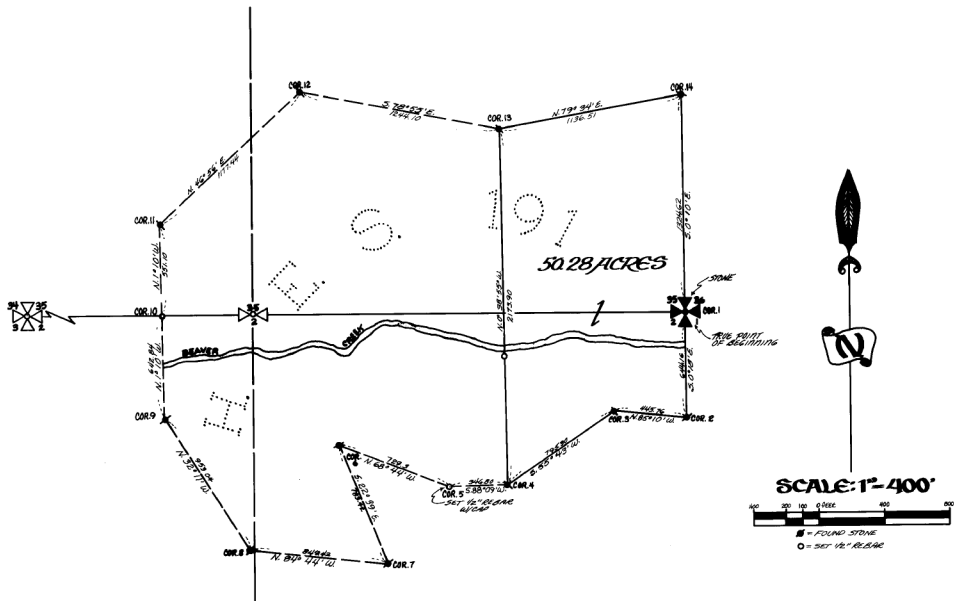


# CERTIFICATE OF SURVEY

### LEGAL DESCRIPTION

THAT PORTION OF H.E.S. 191 IN THE S. 1/2 OF SECTION 35, T. 23 N., R. 31 W. & THE N. 1/2 OF SECTION 2, T. 22 N., R. 31 W., M.P.M., SANDERS COUNTY, MONTANA, DESCRIBED AS FOLLOWS: COMMENCING AT THE NE CORNER OF SECTION 2, WHICH IS ALSO CORNER #1 OF H.E.S. 191, SAID POINT BEING THE TRUE POINT OF BEGINNING, THENCE S. 01° 16' E. 644.14 FEET TO CORNER #2 OF SAID H.E.S. 191, THENCE N. 89° 10' W. 415.76 FEET TO CORNER #3, THENCE S. 55° 43' W. 795.30 FEET TO CORNER #4, THENCE N. 02° 38' 53" W. ON A LINE BETWEEN SAID CORNER #4 & CORNER #19 OF SAID H.E.S. 191 A DISTANCE OF 817.84 FEET, THENCE N. 70° 14' E. 136.51 FEET TO CORNER #41, THENCE S. 01° 16' E. 1364.66 FEET TO THE TRUE POINT OF BEGINNING, CONTAINING 50.28 ACRES.

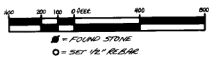
### LAND SURVEYOR'S CERTIFICATE
