LOT 28, MAYPORT HARBOR AND LOTS 29 AND 30, SHOREWOOD ADDITION TO MAYPORT HARBOR CONTAINING 2.92 MORE OR LESS ACRES OF LAND ALL AS SHOWN HEREON.

THE ABOVE DESCRIBED TRACT OF LAND IS TO BE KNOWN AND DESIGNATED AS AMENDED SUBDIVISION PLAT OF LOT 28, MAYPORT HARBOR AND LOTS 29 AND 30, SHOREWOOD ADDITION TO MAYPORT HARBOR, FLATHEAD COUNTY, MONTANA. 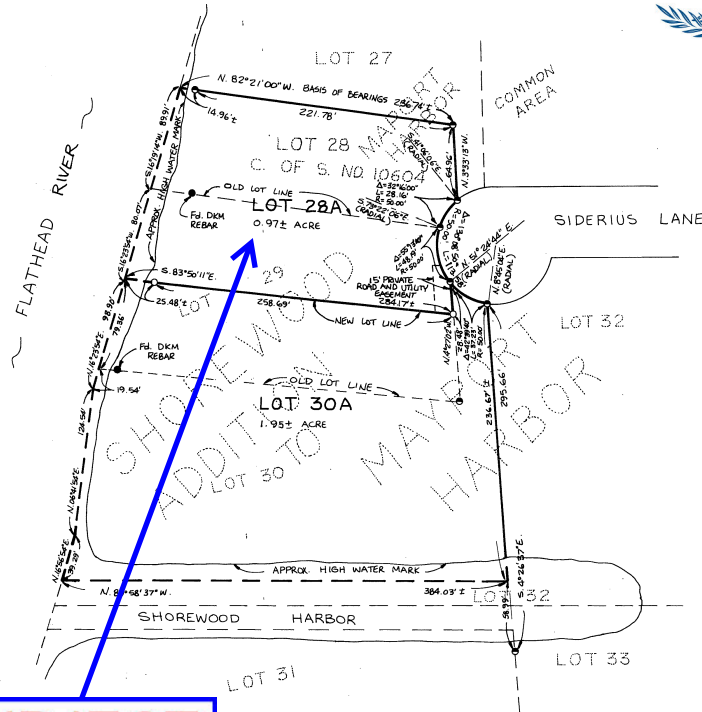

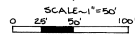
