Located three miles south of Merriman, Nebraska, this is a true representation of the typical Sandhills setting. The Leander Creek winds two miles through the property and is a year-round flowing stream. The creek bottom contains small meadows and the hillsides are scattered with cedar, ash and a few pine trees. The property is fenced into three pastures with newer four wire fences. The two South pastures each have their own windmills with 30 tanks and share a solar well that has a 20 tank in the fenceline. The North pasture is watered by the creek and a windmill with a 30 tank. Two of the windmills/tanks are new as well as the solar well and tank. The rolling Sandhills along with the creek bottom provide excellent mule deer and grouse habitat, with an occasional whitetail. The diverse terrain creates an excellent recreational property that would provide an income.
