The Rumble Creek Road Area in western Montana's Swan Valley is arguably the most exceptional stretch of mountain scenery in Montana. The property consists of just over 30 acres, offering big mountain views east & west, no visible neighbors, and just incredible landscape features: immaculate forest stewardship, seasonal wetland/cattail pond, signature Aspen groves, wildlife habitat, and wildlife galore. The building site has been carefully prepared, in a way that morning sun, late afternoon shade, winter sun, walk-out basement, if desired, are all possible. Utilities include underground electric, phone, hi-speed DSL, 27 gpm water well. This offering is "ready to build", or "hold for the future", as property taxes are very low (less than \$3 per acre per year). Exceptional properties like this will not be available forever. All of the "urban amenities" are about 50-70 miles away, either Kalispell or Missoula. An adjacent 10 acre parcel is also available and would provide further development options for additional structures for family & friends, family pets, on-site caretaker, etc.
