Hunt on your own property or on the surrounding National forest. A back up generator is hooked up just in case.

The home boasts granite counter tops and hardwood (pecan) flooring. The complete remodel also includes new carpet, new appliances, new lighting, new kitchen, new bathrooms, and all new paint. The guest cabin has a full bathroom and laundry area.

The property is set up perfectly for preppers with plenty of storage, back up generator, garden area, great fishing, and hunting.

The shop is insulated, has a cement floor, wood stove, and has 220 amps. The yard has been completely landscaped and has an underground sprinkler system.

Wildlife seen on this property includes bears (including Grizzly), elk, deer, bighorn sheep, eagles, moose, and all types of waterfowl and other native birds.

This property is located just minutes from Bull Lake, the Ross Creek Cedars, and the Cabinet Gorge Reservoir. Also close

to numerous USFS trailheads and the Swinging Bridge on the Kootenai River. The Bull River Valley is an undiscovered gem with some of the most spectacular scenery in the entire area.

The property is protected by a conservation easement that ensures that this property will never be subdivided and it maintains a buffer for wildlife habitat.
