The 160 acres is completely surrounded by forest service property . Area attractions include: Schweitzer Mountain Resort, Lake Pend Oreille, Sandpoint Idaho, Lake Coeur d' Alene, Noxon Reservoir, Quinn Hot Springs and much more.

35,350 sf of quality construction offered at just under \$100/sf includes 16 bedrooms and 16 bathrooms spread out through the Chapel, Chalet, Shop, Dining Hall and Green House. The property can accommodate 120 guests and includes a new sauna. The 3 bedroom caretaker's ranch home boasts a beautiful stone fireplace and many upgrades. There is a rock quarry on the property which the dining lodge wall and upper level fireplace are constructed of. Dining hall fireplace also has a fire pizza oven.
