Wilderness Waters on Elk Creek – Located in the Swan Valley, this 160-acre property is at the end of the road and is surrounded by US Forest Service land. Elk Creek flows out of the nearby Mission Mountain Wilderness and this is the first private land this treasured bull trout spawning stream with crystal clear waters flows through. The log homestead cabin was constructed in 1945 and has been immaculately maintained with a serene sleeping porch above the creek and a modern bath addition, all complemented by a full RV hook up, well and modern septic system, power, and phone. If you seek absolute privacy, this is it! The Elk Creek Trail leads from the property upstream to the Mission Mountains providing unbelievable scenery. The property consists of 8 legal parcels, with legal deeded access granted for up to 4 homesites through the adjacent Forest Service. The property is rolling with scenery beyond compare, from the forest that has been managed for western larch and fir trees, 750 feet fronting on both sides of Elk Creek, wildlife such as elk, whitetail deer and bears. The alternate primary building site for a new residence or lodge with Mission Mountain views overlooking the rushing waters of Elk Creek, high vistas offering majestic Swan and Mission Mountain views. This is a very rare opportunity to consider for your family retreat, lodge, camp or private residence. Missoula and Kalispell airports, Whitefish Mountain ski area, and Glacier Park are each accessed by a 1.5 hours drive.
