Hunters benefit from Idaho's over-the-counter elk tag availability and annual deer hunting opportunities, making this an ideal base camp for multi-species pursuits.

Located just 30 minutes from Priest River, the property offers convenient access to essential services while maintaining true backcountry solitude. The surrounding Selkirk Mountains provide world-class outdoor recreation, from trophy elk hunting in dense timber to open-country mule deer opportunities at higher elevations.
