Extremely private & quiet, bordered on two sides by USFS and at the end of the road, this level 20-acre horse property is ready for you, your horses, & your dogs! Includes a metal sided 40 x 68 x 16 shop house built in 2023 with 4 horse stalls, full RV hook-up, 15 gpm well, spring water rights, septic system, 40 x 56 x 14 pole barn with two 12 ft lean to's on each side, 28 x 36 cinder block structure, 6 frost free spigots, and unlimited wildlife. The main shop house has 2,884 sq ft of living space with 3 bedrooms and 3 bathrooms. On the main level is the kitchen, walk in pantry, utility room, living room, bedroom, and bathroom. Upstairs is a primary bedroom with ensuite bathroom, guest bedroom, guest bathroom, an office, large workout room, storage room and a 2nd story deck. The shop area is 1920 sq ft and the 4 horse stalls are 10.5 x 16, with an 8 ft walkway between. There is a 12-ft lean-to off one side for storage & a separate large chain link dog area connected to the shop.

The living area is heated with a Fujitsu forced air & heating unit with a heat pump. There are also two wood stoves, one on each level. The home has extra insulation with spray foam and Rockwool insulation. The home has a standby 23 KW Generac generator, run by propane and there are two propane tanks on the property that are leased. The shop has a propane wall mounted heater. The pole barn was built in 2023 and is 40 x 56 x 14 with two 12-ft lean to's on each side. The cinder block structure was built in 1979 and is 28 x 36. The property is set up for horses with fencing and corrals. This area is

known for abundant wildlife including elk, deer, rabbits, wild turkeys, and grouse. The property is bordered on two sides by USFS land and is level and has mature trees. The trees could be thinned out to open up a great view of the Noxon Reservoir. The property is set up for horses and dogs and has various fruit trees and berries. Ready for your finishing touches!
