The fully finished lower level includes a large family room, full bar with marble counters and stainless fridge, a bedroom, ¾ bath, and walk-out access to a covered stamped concrete patio and above-ground pool. The highlight? A massive 54x72 barn with metal siding and roof, full concrete floors (6" thick), power, loft space, and three 14x14 insulated roll-up doors. The barn also includes a 15x70 drive-through covered area, heating and cooling, full spray-foam insulation, and two 300,000 BTU Reznor heaters. Inside, you'll find finished office space, a conference room with kitchenette, a ¾ bath, and central air. The barn has its own 200-amp service, gas furnace, and propane (leased tank). Additional features: 400-amp service at the house, central air, septic, public water, and both tank and tankless water heaters. This is a rare opportunity to own a move-in ready home with a fully equipped shop setup—perfect for home-based business, hobby space, or serious storage needs.
